I hereby agree as an entertainer in the CFMA farmers' markets that I am responsible for my own transportation to market locations, and that I will maintain vehicle liability insurance for the vehicle used that market day, and where applicable, product liability insurance, in effect while I am a participating in any CFMA farmers' market.
