I/We hereby agree, as an arts and crafts producer at a CFMA's certified farmers' market, that I/ we will indemnify and hold harmless the sponsors of the market site, the CFMA, their agents and employees, from and against any and all liability, claims, demands, expenses, fees, fines, penalties, suits, proceedings, actions and causes of action of any and every kind and nature arising or growing out of or in any way connected with my/our use or occupancy as an arts and crafts producer at a California Farmers' Markets Association certified farmers' market.

I hereby agree as an arts and crafts producer in the CFMA farmers' markets that I will maintain vehicle liability insurance for the vehicle used that market day, and where applicable, product liability insurance and worker's compensation insurance, in effect while I am a participating in any CFMA farmers' market.
